

FIRSTNET RFP: STATEMENT OF OBJECTIVES

- FirstNet has adopted an *objectives-based approach*, rather than a traditional requirements-driven model.
- FirstNet provides a Statement of Objectives (SOO) listing 16 high-level objectives. Potential contract awardees must demonstrate in their proposals that they will meet all of the stated objectives.

FIRSTNET RFP: PRICING

- FirstNet describes the contract as an "Indefinite Delivery/Indefinite Quantity" (IDIQ) contract, whereby the offeror provides proposed pricing for the entire term of the agreement.
- The agreement is expected to run for 25 years.
- The price structure is composed of two types of payments—
 - (1) Payments to the Contractor
 - (2) Payments to FirstNet.

FIRSTNET RFP: PAYMENTS


- Payments to Contractor:
 - Upon reaching specified milestones, Contractor may draw the remaining \$6.5 Billion provided by Congress
 - The Contractor retains all revenue it collects from other sources, including:
 - Public Safety Revenue, the fees the Contractor charges to public safety agencies associated with using the NPSBN
 - Excess Network Capacity Revenue, any revenue Contractor derives from the lease of network capacity that is unused by public safety.
- In return, the Contractor must make annual payments to FirstNet totaling \$5.625 Billion over 25 years to ensure "FirstNet Operational Sustainability."

NATIONWIDE NETWORK COVERAGE

- As with other key elements of the Request for Proposals (RFP), FirstNet provides objectives for coverage and expects Proposal Offerors to describe their solution for achieving those objectives.
- FirstNet provides coverage definitions and objectives, as well as a nationwide coverage objective map to identify areas where public safety requires both continuous coverage and temporary coverage solutions.

COVERAGE OBJECTIVE MAP BASELINE

- The FirstNet baseline version of the coverage objective map was created from five distinct data sets identifying areas that are likely to require a public safety response:
 - Public Safety Users
 - Public Safety High-Risk Areas of Interest
 - U.S. Population
 - Developed Areas
 - Roadways



The baseline objectives (gray) were updated to incorporate federal (purple) and state (green) inputs, where available.

LOCAL CONTROL TASK TEAM

- 15 distinguished public safety leaders, chaired by BayRICS GM Barry Fraser.
- When will responders need to manually control Priority and Preemption functions of the network?
 - Evaluated a series of increasingly complex use cases.
 - Reviewed the dynamic control capabilities of LTE technology to automatically minimize or eliminate network congestion.
